PERSONAL DATA PROTECTION AND IMAGE PROTECTION

1. The administration of the personal data provided to the kindergarten is the entity that manages the kindergarten, Danuta Lewandowska.
2. The legal basis for processing of personal data by kindergarten is Article 6 paragraph 1(b) of European Parliament and Council Regulation (EU) 2016/679 of 27 April 2016 on natural person protection regard to personal data processing and on free movement of personal data and repeal of Directive 95/46/WE (General Data Protection Regulation) (Journal of laws U. EU L. of 2016 No 119, p.1) – hereinafter referred to as GDPR (i.e. the processing is necessary for the performance of the contract, or to take action at the request of the entity providing personal data before the conclusion of the contract), Article 6 paragraph 1(c) of GDPR (i.e. the processing is necessary for compliance with a legal obligation to which the kindergarten is subject, such as an archiving obligation) and Article 9 paragraph 2(f) of GDPR (i.e. the processing is necessary for the establishment, exercise or defence of legal claims).
3. Providing personal data is voluntary, but necessary to carry out the recruitment process.
4. Recipients of personal data will be in particular entities, to which the Administrator is obligated to provide data under the application law, including the Revenue Service, as well as its subcontractors and entities providing legal services to the Administrator - accounting services, courier shipments and mail services.
5. Personal data will be processed for the entire period during which the contract will be performed, and later, i.e., until the expiry of the limitation period for possible claims resulting from the contract and in connection with the implementation of the 10-year archiving obligation.
6. Everyone has the right to access their personal data, to correct them, to request their removal or the right to object to their special situation. Everyone also has the right to request the Administrator to limit the processing of their data, as well as to transfer them.
7. Everyone, in the event that his/her personal data is processed in violation of the requirements of the law, has the right to lodge a complaint with the supervisory authority, which is the President of the Office for Personal Data Protection.
8. Personal data is protected in accordance with the GDPR and the Personal Data Protection Act in such a way as to prevent third parties from accessing them, subject to paragraph 9.
9. The Customer agrees to take photos, videos with the participation of the Participant, reporting events from the life of the group, as well as to publish them on the website and social profiles of the facility for promotional and marketing purposes.
10. The Customer who does not consent to the activities referred to in paragraph 9 may make an appropriate statement in this respect.
11. The kindergarten undertakes to maintain all ethical principles, so as not to adversely affect the image of the Participant and its closest relatives.
